**Date limiters** are available in which you can select single dates or ranges for date of **publication** and date **last updated** (i.e., the date the document was loaded or updated on ProQuest Dialog).

## ***BROWSE FIELDS***

You can browse the contents of certain fields by using Look Up lists. These are particularly useful to validate spellings or the presence of specific data. Terms found in the course of browsing may be selected and automatically added to the Advanced Search form. Look Up lists are available in the fields drop-down and in the search options for:

### **Author, Author affiliation, Subject**

and in the fields drop-down only for:

## ***THESAURUS***

The FSTA™ thesaurus is available by clicking on the “Thesaurus” hyperlink on the Advanced or Command Line Search pages. Thesaurus terms may be searched within the thesaurus, then selected to be added automatically to the Advanced or Command Line Search forms.

## ***“NARROW RESULTS BY” LIMITERS***

When results of a search are presented, the results display is accompanied by a list of “Narrow results by” options shown on the right-hand panel. Click on any of these options and you will see a ranked list showing the most frequently occurring terms in your results. Click on the term to apply it to (“narrow”) your search results. “Narrow results by” limiters in Food Science and Technology Abstracts include

**Author, Language, Publication Title, Subject, Document Type and Publication date.**

## ***LOOK UP CITATION***

If you need to trace a particular bibliographic reference, use the Look Up Citation feature. Find a link to this toward the top left-hand corner of the Advanced Search page, or in the drop list under Advanced on any search form; click this and you will go to a form where you can enter any known details of the citation, including document title, author, journal name, volume, issue, page, publication date, ISSN.
